Sub.: Amendment in the Standard EPC Agreement for considering maintenance payment exclusive of GST and reimbursement of GST at applicable rates- reg.

In EPC projects Contract price put to tender is exclusive of GST and as per Article 14.1 maintenance amount is calculated as percentage of contract price.


2. In view of above, as Contract Price is exclusive of GST the maintenance payment shall also be exclusive of GST. Accordingly, it has been decided to modify Article 14.1 of Standard EPC Agreement as under:
